Legislative Committee Report	Joe Bradshaw reported. Last March Joe Bradshaw, Mark Harrison, and Sherman Hockenbury represented KAPA in meetings in Washington, DC. Meetings were scheduled with all of our legislators and with the National Ambulance Coalition (NAC) representatives. It is felt by the committee that these meetings have been very beneficial and that we are beginning to see positive results.	
Medicaid Report	Sherman Hockenbury reported. Presently, Kentucky Medicaid is spending 12million dollars annually on EMS. About one third of this is going to air ambulance providers. Rep. Nunn filed a bill during the last session, which called for Medicaid rates to be increased to equal rates under the Medicare Fee Schedule. Many KAPA supporters cosponsored the bill. Although the bill did not pass, it provided the much-needed opportunity to discuss the Medicaid reimbursement issues in a public forum. Recently, Medicaid announced that EMS would receive a 14% increase (just over \$2 million annually) effective July 1, 2005.	
	A bill has been recently introduced in Congress, which if passed, would increase Medicare reimbursement to EMS. Kentucky's share would be \$10 million annually.
